Code Enforcement

Each region will feature 1-2 code enforcement officers who will discuss housing and habitability issues with compulsive hoarders, and how cities and counties enforce laws and regulations affecting hoarders. In addition, they may highlight programs or services to help compulsive hoarders come into compliance with housing regulations.

Goals

The goals of this training are to:

1. Increase the APS worker's knowledge of compulsive hoarding behavior and its treatment based on current research and clinical experiences
2. Increase the APS worker's knowledge of current code enforcement issues affecting compulsive hoarders
3. Improve APS workers' ability to more effectively assist compulsive hoarders

Objectives

At the end of this training, APS workers will be able to:

1. Differentiate normal cluttering and hoarding from compulsive hoarding
2. Understand how compulsive hoarding is diagnosed and treated
3. Learn practical and effective tips for helping compulsive hoarders
4. Decide when to bring in professional counselors and organizing experts to help compulsive hoarders in dealing with their disorder
5. Understand specific health and safety, and housing, codes that compulsive hoarders may be violating
6. List the elements that code enforcement personnel are looking for when dealing with compulsive hoarders

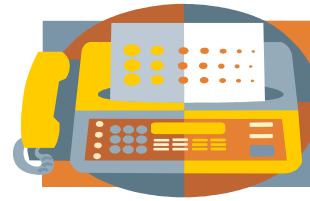
